### **ACCIDENTS IN THE WORKPLACE**

The majority of workplace injuries are the result of slips, trips or falls, manual handling, or falls from height. However, incidents involving machinery/tools, and injuries involving vehicles also occur in high numbers. Our specialists routinely carry out both the physical examination of materials associated with the incident, as well as an evaluation of relevant documentation, such as Risk Assessments and Systems of work.

### **CHEMICAL INCIDENTS**

When dangerous chemicals or materials are involved in a failure, the consequences can be life threatening. Increased scale of production of pure substances comes with many increased risks. Fires, explosions, toxic gas clouds, and chemical leaks, can all cause potential injury and future long-term health effects. In particular, asbestos continues to cause health issues as well as difficulties in the refurbishment and demolition of many buildings. Hawkins can investigate what has caused a chemical incident and advise on both liability and recovery.

#### **CONSTRUCTION SITE INJURY**

Despite concerted efforts to tighten regulations, construction continues to be the most dangerous industry in the UK. All our investigators have both design and site experience with some of the most prestigious international design consultants and on the most complex construction sites. We can assist you with pre-loss risk management, forensic investigation, expert witness services through to through to post-loss advice.

### **FALLS FROM HEIGHT**

We investigate the nature of the fall and causation. We can provide advice on whether any defects were present, (e.g. in windows), or whether the relevant construction met British/European Standards, as well as confirm which building regulations may apply and whether these have been met.

#### HAND-ARM VIBRATION SYNDROME

Use of vibrating hand-held tools, such as jackhammers, can increase the propensity of HAVS whilst exposure of the whole body to vibration, and shocks, through the use of large machinery, such as earth moving machinery can also lead to musculoskeletal problems. Hawkins can measure and assess vibration exposure to identify machinery which may cause harm to workers.

### **HEALTH & SAFETY REVIEWS**

We assess existing procedures to determine the efficacy and effectiveness of Health & Safety policies. We review risk management strategies, reporting arrangements, and the actions taken to identify and rectify potential weaknesses. Our services include pre-loss risk management to support implementation of the correct procedures as a preventative action, through to an investigatory role should a health and safety incident occur.

### MANUAL HANDLING

Manual handling is defined by the HSE as transporting or supporting a load by hand or bodily force. It is a common risk in industries and workplaces, including construction sites, warehouses, and offices. Our detailed investigation determines the direct cause of the accident, as well as all contributory factors. We assist you in ascertaining whether your client has a valid claim or is liable for the injury.

#### **NOISE-INDUCED HEARING LOSS**

Noise-induced hearing loss is one of the most insidious injuries and is tightly regulated under the Control of Noise at Work Regulations. We can provide an assessment of your work environment ranging from simple spot measurements or personal employee assessments, development of a full Hearing Conservation Program through to expert guidance in the event of litigation.

## **OCCUPATIONAL HEALTH**


