Throughout a 25 year career as an NHS Consultant ENT Surgeon (35 years working in the NHS in total), my main interest is in otology but I also specialise in Facial Plastic Surgery, especially rhinoplasty (over 2500 operations), as well as general ENT adult work. I have performed over 3,000 major ear operations, where my main interest is in stapedectomy, usually performed under local anaesthetic (530 cases), and have received referrals from a large catchment area, well beyond my own department.

Since retiring from the NHS I work full time in private practice, dividing my time between medico-legal work and clinical practice.

I have over 50 publications in reputable journals (including leading articles in the British Medical Journal). Main subjects include local anaesthesia for middle ear surgery, nasal physiology (rhinomanometry), flexible rhinolaryngoscopy, and stapes surgery.

I regularly lecture locally, and have also lectured nationally, and internationally on a variety of topics.

I am principal examiner and medical lecturer for nurses on the national ear-care course based in Rotherham. I continue to examine medical students (finals and 2nd MB), and interview potential students at Sheffield University for entry into medical school. I was an Assessor for the Royal College of Surgeons of England, representing their interests on Advisory Appointment Committees (for Consultant Surgeon appointments) (2005-2015).

Medico-Legal Work :

I have carried out medico-legal work for 30 years. I have seen over 10,000 patients. Many relate to claims for industrial deafness, although I also carry out other cases related to personal injury within the realms of my expertise (rhinoplasty, otology, general adult and paediatric ENT). For industrial deafness cases, approximately 90-95% of the work is on behalf of the Plaintiff and approximately 5% on behalf of the Defendant, with occasional cases as SJE work, issuing reports as a joint expert for both parties. I attend court on 6 occasions per year.

For non-noise deafness cases I deal with clinical negligence/personal injury claims for both defendant and claimant in approximately a 50/50 ratio.

Areas of Expertise

I have issued medico-legal reports since 1988, and issued many thousands of reports, I therefore have sufficient experience to deal with most problems.

Otology, noise-induced hearing loss, otosclerosis and stapedectomy, mastoid and other ear diseases, **rhinoplasty**, bat ears, general ENT (tonsils, nasal septal surgery etc), examples of cases I will deal with;

- ear disease-all aspects including NIHL (noise-induced hearing loss), head injuries, whiplash causing tinnitus, tinnitus other aspects, dizziness/vertigo, post-operative complications, consent issues, ototoxicity-(I have carried out over 3000 major ear operations)
- facial plastic surgery-rhinoplasty (over 3000 cases), bat ears, skin tumours
- general rhinology - septoplasty, sinus surgery, nasal obstruction
- tonsils and adenoids
- endoscopic ENT complications

Terms and Fees

My waiting list is approximately 1 month, with reports turned around in approximately 1 month, subject to review of medical records, and any other specific matters requiring extra attention.

My fee is £250 per hour plus VAT. A simple industrial deafness report would typically cost £750 (military cases £800) for the report including consultation, audiogram and review of medical records, plus VAT, and a complex personal injury/medical negligence case being in the region of £2000 + VAT, depending on the time involved.
