Synopsis of Medico-Legal Experience

Clinical Negligence and Personal Injury

I have over twenty years' experience of providing medicolegal reports and undertaking expert witness work in Emergency Medicine. I have provided over 1800 clinical negligence reports, comprising of a mixture of fixed-fee overview reports and more detailed negligence reports concerning breach of duty in Emergency Departments. I am regularly instructed by many of the NHSR panel firms for clinical negligence, as well as receiving claimant firm instructions.

I have considerable clinical experience of the whole spectrum of Emergency Medicine presentations and have I provided reports on a wide variety of trauma and illness presentations. Examples of areas where I have provided reports are listed below:

Subarachnoid haemorrhage, head injury and stroke including thrombolysis.

Missed spinal fractures

Scaphoid fractures

Missed fractures/soft tissue injuries of limbs including tendon injuries and wound management.

Hip and knee injuries

Cauda equina/discitis/back pain

Heart attacks (Myocardial Infarction)

Deep venous thrombosis and pulmonary embolus

Achilles tendon rupture

Ischaemic limbs

I am able to assess Personal Injury Claimants in rooms in Lancaster, LA1 4RP usually within two weeks of being instructed or if appropriate an assessment can be undertaken remotely via teams or WhatsApp.

As an Examiner for the Royal College of Emergency Medicine (since 2010) I maintain knowledge of current best practice in Emergency Medicine, I have written evidence of five years CPD sign off, and I revalidated with the GMC in 2020.

I have master's degree in medical law (LLM), so I am conversant with Medical Law issues relevant to clinical negligence, as well as being familiar with Civil Procedure Rules. My reports are drafted with a familiarity with legal writing, the requirement to separate issues of fact from opinion, and to provide an opinion on what a reasonable spectrum of practice would be for any clinical presentation.

I am able to comment on the standard of care provided by all clinical staff working in the Emergency Department or minor injury unit environment including the practice of doctors, paramedics, nurse practitioners and physician associates.

My defendant: claimant split is approximately 75%:25%.

Expert Witness / Criminal Law

I receive regular instructions from the Police, Coroners, IOPC, GMC and the Health Professions Council, to comment on the standard of care provided by medical practitioners in Emergency Medicine, as well as paramedics and other related disciplines.

Court Work

I have given evidence in court as an expert witness in Inquests and criminal cases (including murder and manslaughter).

I have appeared as an expert witness in GMC 'Fitness to Practice' tribunals. I have experience of conferences with other experts and Counsel in preparation for progression of negligence claims.

Turnaround for reports

I operate a paper-light office and am used to receiving instructions by secure electronic means (such as mimecast). This means that I am able to guarantee to produce reports within two weeks of instruction, and sometimes faster if a deadline demands it. I am always available by telephone to answer any queries about cases.
