My Current Terms of Engagement are:

- 1. My current hourly fee is £170 for all time spent on the case, which includes telephone case conferences and supplementary reports. (Most reports require 2-4 hours preparation for the primary report).
- 2. I charge a one off fee of £50 for uploading cases to a diagnostic PACS workstation for radiology image review.
- 3. My daily rate for attending Court hearings is £1360 which includes time for travelling and waiting. I expect payment even if I do not give oral evidence. This rate also applies for case conferences where personal attendance is required.

Dates for court must be provided at least 6 weeks in advance.

Cancellation fees for Court:

Greater than 6 week's notification: No Charge

3-6 weeks notification: 50% of daily rate for total no. of days
Less than 3 weeks notification: 75% of daily rate for total no. of days
Less than 1 week notification: 100% of daily rate for total no. of days

4. I will also invoice you for any reasonable expenses at cost, which may include 1st class rail or flight fares, taxi fares and hotel tarriff for overnight stays. Any necessary car mileage will be charged at 15p per mile. Copies of receipts will be provided on request.

- 5. In legally aided cases (where my fees constitute a disbursement), I expect you to make a prompt claim to the legal services Commission, and to advise me of any expected delay in settlement. In all other cases I expect payment within 30 days of invoice date from you my clinet, irrespective of whether your client has paid you.
- 6. Should accounts not be settled within the agreed period, at my discretion, I have the right to charge interest on unpaid accounts at the rate of 2% a month, or part of a month, until full settlement is recieved.
- 7. I am not prepared to have my accounts subjected to assessment and look to you, my client, to fund any assessment deducted relating to the Case, at any time.
- 8. I will use my experience, care and skill in fulfilling your instructions to the best of my ability. Please remember I am an independant witness.
