Clinical and Academic Profile

I am a Consultant Urological Surgeon at Sheffield Teaching Hospitals. I have a specialist interest in urinary tract reconstruction and work within a team that provides an internationally recognised tertiary referral service. My areas of specialist expertise are in the treatment of urethral strictures, complex incontinence, urinary fistula, refractory bladder problems and urinary tract injuries arising from trauma or surgery. I also have a busy practice in general urology.

I completed medical studies at the University of Liverpool graduating with honours. I undertook specialist training in Urology in Merseyside and Yorkshire between 2010 and 2018. The last 2 years of my training were exclusively in reconstruction. This was followed by focused training in vaginal reconstruction in Moscow in 2019.

I have undertaken research into tissue engineering and regenerative medicine for urinary tract and pelvic reconstruction leading to the award of a PhD (2014). I regularly act as an investigator in clinical trials for lower urinary tract disorders. I have regularly presented my research at national and international meetings in addition to giving invited presentations. I have published over 90 articles as well as 20 book chapters and 3 books.

I serve on the editorial board of the premier journal in functional urology, Neurourology and Urodynamics, as well as being a reviewer for several urology and science journals. I am a member of the European Association of Urology (EAU) Urethral stricture guideline panel, the EAU young academic urologist's functional urology group and a member of the International Continence Society working group on Underactive bladder. In 2019, I was selected as one of 3 urologists from across Europe for the EAU/American Urology Association academic exchange, when I visited centres across the USA to further my expertise.

Medico-legal Profile

I have a longstanding interest in the medico-legal issues in urology. I have undergone training in medico-legal report writing. I keep up to date with medicolegal developments. I am aware of the requirements of Part 35 and Practice Direction 35, the Protocol for the Instruction of Experts to Give Evidence in Civil Claims and the practice direction on pre-action conduct. I published the first national analysis of urological litigation in the UK (Osman NI, Collins GN. Urological litigation in the UK National Health Service (NHS): an analysis of 14 years of successful claims. *BJU Int* 2011;108:162-5). This has become the most widely cited work on the topic.

I have specialist knowledge and expertise in

- gynaecological and other surgical injury to the urinary tract
- Urinary tract trauma
- Neuro-urology
- Urological consequences of spinal cord injury and cauda equina syndrome.
- bladder overdistention
- pelvic fracture injuries resulting in urinary and sexual problems

- Circumcision related problems
