### **EXPERIENCE**

#### **1 CLINICAL**

I have practiced Otolaryngology for more than thirty years and gained a wide range of experience in adult and paediatric ENT practice in outpatients and theatre.

This experience was expanded especially as a Consultant when I was successfully appointed in a substantive Consultant post in Taunton, Somerset.

#### ***SUMMARY OF CLINICAL EXPERIENCE***

##### **Otology**

I have extensive experience in clinical and surgical otology. I have performed most otological procedures including tympano-mastoid surgery, stapedectomies, bone-anchored hearing aids. I have been exposed to cochlear implant surgery and neuro-otology. I also have experience in special investigations including ABR, autoacoustic emission and image interpretation. I have gained experience in using the KTP laser in otology particularly for the surgery of meatal stenosis, stapedectomies and mastoid surgery.

### **Rhinology**

I also have substantive skills in rhinology especially in functional endoscopic sinus surgery and rhinoplasty, having performed almost three hundred cases of the latter. I have experience in endoscopic dacryocystorhinostomy using the KTP laser.

### **Head & Neck Surgery**

I am the Thyroid Lead for Taunton & Somerset NHS Foundation Trust

I have gained substantive experience in salivary gland, thyroid and head and neck cancer surgery. I have also used the KTP and CO2 laser for laryngeal surgeries. I also managed a number of patients in the special voice and dysphagia clinic where I gained experience in evaluating these patients using fibre-optic endoscopy and video-fluoroscopy. In addition, I managed a large number of patients who underwent primary voice restoration following laryngectomy.

### **Paediatric Otolaryngology**

I gained my experience in the Gulf and this was expanded at Birmingham Children's Hospital where I worked for six months. I managed a great variety of cases with upper airway disorders including stridor, choanal atresia and sleep apnea. I also participated in the cleft palate clinic. I was also exposed to cochlear implant surgery.

I have special experience in the management of congenital choanal atresia having treated several cases and invented the "Sadek Choanal Atresia Stent" which is used worldwide.

## **2 TEACHING**

I was the Specialty tutor for ENT

I am the Assigned Educational Supervisor for the SPR. I plan his training while in our department for 12 months. I assess him on regular basis and I am his mentor.

I am the educational supervisor for the F2 trainees. The F2 trainees are in our department for 4 months and have two formal assessments in that period. I also report to the MMC about their progress.

I have received training in selection methodology for the short- listing and interviewing the ST and FTSTA applicants nationally.

I attended “Training the Trainers course” at Keel University to improve my teaching skills.

I am responsible for the Trust consent policy to the surgical department and newly appointed juniors. This involves lecturing and teaching them about consent and signing them off as competent to seek surgical consent from our patients. This is done with every newly appointed junior.

I am one of the lecturers at our yearly GP training day

I have participated in the training of the nurses for the POAC including consent procedure

I am also a speaker on the Specialist Registrar training day

I am also very active in the clinical teaching of medical students

I am a member of the Court of Examiners for the MRCS, The Royal College of Surgeons of England

To assist Senior House Officers and Casualty Doctors, I have written and published a handbook titled “Pocket ENT Emergencies”.

### **3 MANAGEMENT**

I am the clinical service lead for the ENT and Head & Neck department (2009).

I am the departmental lead for patient consent and patient information leaflets.

I have written several surgical leaflets. These leaflets help patients to understand in layman terms the surgical procedure and potential complications. It also outlines the admission process, post operative care and follow-up.

They form an important part of informed consent

I am responsible for the juniors’ leave and management of necessary cover.  
I was an assessor for PMETB for article 14 applicants.

I attended a clinical management course at Keel University on November 1999 and found it to be very insightful as it highlighted the structure and organisation of management

within the NHS. This helped me in my administrative responsibilities in running the department and in dealing with colleagues and patients effectively.

#### **4 MEDICAL AUDIT**

As a Consultant and Audit lead, I was in charge of the audit function of the Department. Departmental audits are conducted involving all colleagues in the ENT Department including the nursing staff. This led to changes in practice with new protocols resulting in higher success rates with fewer complications and better outcomes.

### RESEARCH & INNOVATIONS

#### RESEARCH

##### 1) *Efficacy of Topical Anaesthesia in Outpatient Flexible Nasendoscopy*

A double-blinded randomised controlled trial investigating the efficacy of lignocaine, lignocaine with phenylephrine, xylometazoline and no preparation in nasendoscopy.

**Conclusion:** Xylometazoline was as effective as lignocaine with phenylephrine.

- 2) *Post-Operative Prophylactic Antibiotics in Tonsillectomy*  
A retrospective study of the value of post-operative antibiotics in 834 cases of tonsillectomy by dissection.

**Conclusion:** There was no statistically significant difference between the proportion of haemorrhage in the groups treated with and without antibiotics.

### **INNOVATIONS**

My experience with ten cases of congenital choanal atresia led me to develop a new method of using endotracheal tubes for stenting, the results of eight cases of which were published in 1997. The absence of commercially available easy-to-use stent for this condition spurred me to develop a design of my own. Patent No (GB 9918973.0) & (US 6,606,995B1). This has been manufactured by Exmoor Plastics and is now available commercially.

The stent would aid treatment of this condition by reducing operative time tremendously, as they are extremely easy to insert. It will also reduce the incidence of restenosis and reduce the number of surgical procedures to keep the newly formed choanal openings patent.

The device is now regularly used at James Cook University Hospital in Middlesbrough, Radcliff Hospital in Oxford and in Spain with great success and to the satisfaction of the surgeons. The device is cost effective as it reduces operative time and does not require a general anesthetic for its removal, thus avoiding unnecessary complications.
